The Lynching Myths

Let's begin here by addressing a few myths regarding lynching incidences involving American Negroes (1882 to 1960).

Myth I:

Prior to the Voting Rights Act (1965), it was very common, particularly in the South, for White people to round up Black men who tried to vote ... and LYNCH them. **Not true.** Didn't happen. I cannot find **ONE** verifiable newspaper account of such an event. Perhaps one or maybe even a few incidents did occur. If so, it/they likely happened during the Reconstruction years (1865 to 1878). Of further note, in 1963, two years before the passage of the Voting Rights Act, **43%** of all eligible Blacks in the South were registered to vote. And if that percent seems low, remember, this was two years prior to LBJ's launching of his Great Society socialist programs i.e. most blacks believed they had little reason to go to the polls and vote prior to 1963, since – the way they saw it – there were no gov't rewards for doing so. There were voting "irregularities" mainly in Mississippi and Texas. (**SOURCE:** *Chronological History Of The Negro — year 1963*)

Myth II:

More Blacks were lynched in the South because that's where most of the racist White people lived. **Not true.** There was without question a determined effort in the South among White people to have the Black race live separately. However, there was, prior to 1964, nothing illegal or even immoral in this desire. Nor was it an act of racism. One distinct people living separate from another distinct people was not just the norm in American history (up until 1964) but human history as well. Regarding lynching... When a White person was attacked (rape or murder) and the perpetrator was Black, this was seen as an attack on "the group" and White people responded more often than not with uncharacteristic ferocity. Blacks were rarely ever assaulted (rape or murder) by a White person in the South. 99.9% of the cases I have found where violence crossed racial lines, it was Black- on-White ... and the result was a raging and maddened mob out for revenge. These were the times in which they lived. The vast number of attacks by Blacks on innocent southern White people, including rape, in this type of atmosphere, boggles my mind. Again, the lynching of Blacks in the South was not about racism. It was seen as a necessary response at that time for a criminal act (usually rape or murder). Here's another point to consider. If racism drove White people in the South to lynch the Black man...then why was lynching dying out in the late 1920s? (in 1929 8 Blacks were lynched; 1935 – 18 blacks lynched ; 8 Blacks lynched in 1936 ; 8 Blacks lynched in 1937; 6 Blacks lynched in 1938; 2 Blacks lynched in 1939 — no one knows how many of these Blacks were lynched by fellow Blacks). Didn't civil-rights activists in the 60s refer to the South as "*the hotbed of racism*"? So why did lynching die out in the so-called racist South? Maybe Black-on-White violence dissipated to almost nothing starting in the late 1920s? Hmm. I doubt it. I believe lynching died out for two main reasons: 1) It lost its manly appeal – the feeling that it was every man's responsibility to enforce the law and not just the sheriff; 2) It FAILED to stop the black males' predatory assaults on white females/ males and law enforcement officers.

Myth III:

White people lynched 3,446 Negroes between 1882 and 1968. **Not true.** First, the lynch figure for Blacks has been reduced downward to around 3000 ([LINK pg#9](#)). Second, there is no way of knowing precisely how many of the lynched Blacks were lynched by fellow Blacks. No question about it though, White males were ready to lynch a Black male (or even a black female) for any murder, rape or sexual assault of any kind perpetrated against a White person. **Those were the times in which they lived.** Blacks were fully aware what crimes could provoke a lynching. After all, Blacks were lynching Blacks for the very SAME crimes.

NOTE: The lynching figure for Blacks would be much, much, much higher, if not for White law enforcement protecting them from raging mobs. – [LINK \(note the reasons cited for the lynchings\)](#)

MYTH IV

Blacks were so terrorized by racist white southerners they acted sheepish and frightened around them... never knowing if they'd be lynched for no reason whatsoever. **Not true.** Here are a few examples of black behavior in the early 1900s toward white people.

1. Atlanta, GA. – 1900: Black male bully sat on a white male's lap while riding a on street car, deliberately trying to humiliate and antagonize him. A fight ensued and the black male pulled a concealed gun and gunned down the young white male. Oh, and in the state of Georgia in 1900, the color-line mandate was not being enforced, so blacks could sit where they pleased. [Link](#)

2. Shreveport, La. – 1901: Black Supremacist organization advocated violence against white people. One white male was murdered. [Link](#)

3. Columbus, Ga. – 1900: Negro crawled into the bedroom of young white girl thru an open window and attempted to rape her. [Link](#)

4. Columbus, Mo. 1901 – Negro raped his employer's wife...then shot her in the head

Brother-in-law of murder victim: "I want to speak to him, how many times we cared for him and how kind Mary was to him, and ask him why he killed her. Then, when he has answered that, I want to see him burned." [Link](#)

5. Tuscumbia, Ala. – 1901: It's a MASSACRE – Negro petty criminal ambushed sheriff and deputy and murdered both – he then gunned down seven more white males – four dead. [Link](#) (note: the death count was later revised)

6. Dublin, Ga. -1908: Two Negro employees invaded the home of their [white] employer, beat him senseless with an ax, gang raped his wife ... then slashed her to pieces demanding to know the whereabouts of household money [Link](#)

7. Satton, W.Va. – 1908: Home Invasion By Negroes – White male homeowner was tied to a tree then whipped — negroes then gang raped his wife (no, I'm not kidding) [Link](#)

8. Hot Springs Ark. – 1908: Negro cook decides he gonna have a little fun with hungry young white male – taunts him with food offer – makes him work in the blazing heat until he can't work any longer... Negro then guns him down. [Link](#)

9. Eufala, Ala. 1911: Prominent American woman was stalked by a negro sexual predator as she walked from a neighbor's home to her home. The negro finally grabbed her and wrestled her to the ground. As the negro started to tear her clothes off ... to rape her... her desperate screams for help saved her. White males quickly came to her rescue. [Link](#)

10. Stephensport, Ky. – 1904: [Negroes "Lynch" Young White Male](#) – If Emmit Till murder was a "lynching" than this one should also be judged a lynching as well. Two negro brothers went after a young white male who , their sister claimed, "insulted her". When they found the young white male ... they slit his throat from ear to ear. [source](#)

In America between 1882 and 1968 there were three recognized legitimate sources for lynching data:: Chicago Tribune, Tuskegee Institute and the NAACP. The criteria for a "lynching" (created by the NAACP) requires that four conditions exist : (1) there must be evidence that a person was killed; (2) the person must have met death illegally; (3) a group of three or more persons must have participated in the killings (to rule out personal vendettas, etc.); and (4) the group must have acted under the pretext of protecting justice or tradition. Chicago Tribune began its lynching data in 1882; Tuskegee in 1892; NAACP sometime after 1913.

Note: When you see a reason cited for the lynching on any link, remember this:: When a Black man was found dangling (lynched) by White people, there was obviously no information available to accurately establish a reason for the lynching. So what would the person at Tuskegee (or the Tribune or the NAACP) do for citing a reason for the lynching? Well, he could easily manufacture a

reason. There was no law against this practice. So when you come across preposterous reasons for Blacks being lynched, like "Acting suspiciously", "Quarreling", "Insulting a White man", "Trying to vote", etc., don't believe it unless there is a verifiable source (e.g. newspaper article) and the name of the Negro is given along with the cited reason for the lynching. Also, citing a fictitious reason like "quarreling" has another intended and insidious purpose:: **It implies that 'barbaric' White people did the lynching. Right?**

We'll now look at some examples of Negroes lynching Negroes.



Another example of Negroes lynching a Negro –unknown person and unknown offense (circa 1955) – and found dangling by local white people. A white male rushed home to get his camera to snap this pic before authorities could remove the body. Police also believed suicide was a possibility in this one, since the Negro's hands were not tied.

Here is a black man found dangling by white people. The tell-tale sign Negroes lynched him is that there is no identity given for the Negro ... and no reason given for the lynching i.e. his purported crime.



In this postcard we have four young black males clearly lynched. However, it was falsely claimed (deliberately by white people) on the postcard that white people hung these black males for a gang rape of a white female in Georgia. The reason for making the false claim was likely to intimidate would-be Negro rapists from attacking white females. These blacks were actually hung in Kentucky by fellow blacks in 1908(?), most likely for a murder or gang rape of a Negro.

Note: Could be white male vigilantes hung these four (possible names: John Jones, Virgil Jones, John Boyer, Joe Riley). The four were implicated in the murder of a white male



The Negro rapist was a constant menace to the Americans and Negroes. Here we have another unknown Negro found by white people, who was lynched and riddled with bullets by fellow Negroes. Had this Negro raped and/or murdered a white person, white males would have gathered by the dozens, or hundreds, his name would be known to the local press, and a picture would have been taken immediately after the lynching depicting all the proud [white] participants. Also, note how the black male is holding his groin area, indicating he was protecting that area when shot. This tells us that this Negro was most likely a rapist and the Negro shooters were deliberately shooting at his groin. Pic is circa 1915



Note how this unknown Negro is hung by two chains pieced together. This man, found dangling by white people, was obviously lynched by poor blacks who didn't have a rope. If you enlarge the photo you can see what a haphazard and clumsy job the lynchers did tying the chains together. One can only imagine how long this Negro had to wait while his [black] lynchers tried to figure out a way to fasten the two chains together.

Negroes' Inhumanity Toward Fellow Negroes



The scarred Negro above was a slave most likely owned by one of the largest slaveholders in the state of Louisiana, a Negro

woman named C. Richards (he wondered into a Union army camp not far from her plantation). The widowed Negro, along with her son, P.C. Richards, owned a large – and very profitable – Louisiana sugar plantation and had a stable of 152 Negro slaves. There was a story circulated which claims that this slave, who went by the name of Gordon, was whipped because he was a runaway. But no evidence exists to substantiate this “story.” It could also be that Gordon committed a very serious crime (most likely against a fellow Negro) for which he was punished. Gordon escaped from his master in the spring of 1863 and, after a ten day journey, found sanctuary among [white] Union troops.

Note: If the scars on Gordon’s back did come from a whip, the most likely perpetrator would be the Negro overseer (slave-driver). There is also a claim that Gordon was in the service of the US Army ‘colored’ regiment, however, no record exists to substantiate this claim. Highly unlikely this Negro would flee the slavery of one place (a plantation) and volunteer for de facto slavery in another (US Army). Gordon could very likely have been a lazy Negro who not only didn’t like to work but also didn’t like taking orders. Gordon’s actual whereabouts after this pic was taken are unknown. And one final observation. Gordon’s back scars, which look like they’ve healed many, many, many years prior to the photo, could also be from (indeed, looks very likely) a burn injury. Perhaps thru an accident some hot grease or water spilled on him when he was a young lad. Of course, there would be NO story for Harper’s Weekly magazine if that version was reported.
